Philosophy

European

Religion shapes people's identities and conditions relationships. Contrary to traditional European self-understanding, Europe is multi-religious. People of different faiths and cultures have to work out ways of overcoming historical enmities and find ways of living together peacefully and constructively in the context of Europe's secular societies.

Process-oriented

EPIL offers a unique process of learning through a carefully structured combination of learning methods, comprising academic inputs, live encounters with people and communities, training in intercultural and interreligious learning, and participation in religious and spiritual life.

Innovative

It focuses on women as major agents for developing a culture of peace in everyday life. It focuses on Christian-Muslim relation, an area of potential conflict in European societies. It focuses on persons who in their private and professional lives focus on interreligious issues and dialogue (social workers, civil servants, media workers, church/mosque workers, NGOs, etc.).

Long-term learning

EPIL's new two years long intensive study course is organized in the form of roaming college. Its five modules bring participants from four countries together where they learn from each other through city-based learning groups, meeting between modules, and independent project work.

Why to apply?

- Learn about Islam and Christianity as "systems of being" from participants of different cultural and religious background
- Explore the nature of religious freedom in the secular and democratic context of European societies
- Build awareness of the historical role of Islam in Europe and the way memories shape today's relationships in everyday life
- Analyse conditions that may lead to the misuse of religion for non-religious purposes, and identify ways to avoid it
- Develop a gender perspective, keeping the viewpoint and contributions of women in focus
- Contribute to overcoming violence and promote respect for human rights

- All interested participants can apply through their national groups upon the public call that will be publishet at our web-site (www.epil.ch).
- Participants are required to pay fee and should contact their national facilitator for more information.
- To obtain a diploma, participants are required to follow the entire course and submit a diploma work or project. The diploma is awarded by EPIL.
